ளும் இணைந்துகொள்ள வேண்டுமென்று இவர் வேண்டுகோள் விடுக்கிறார்

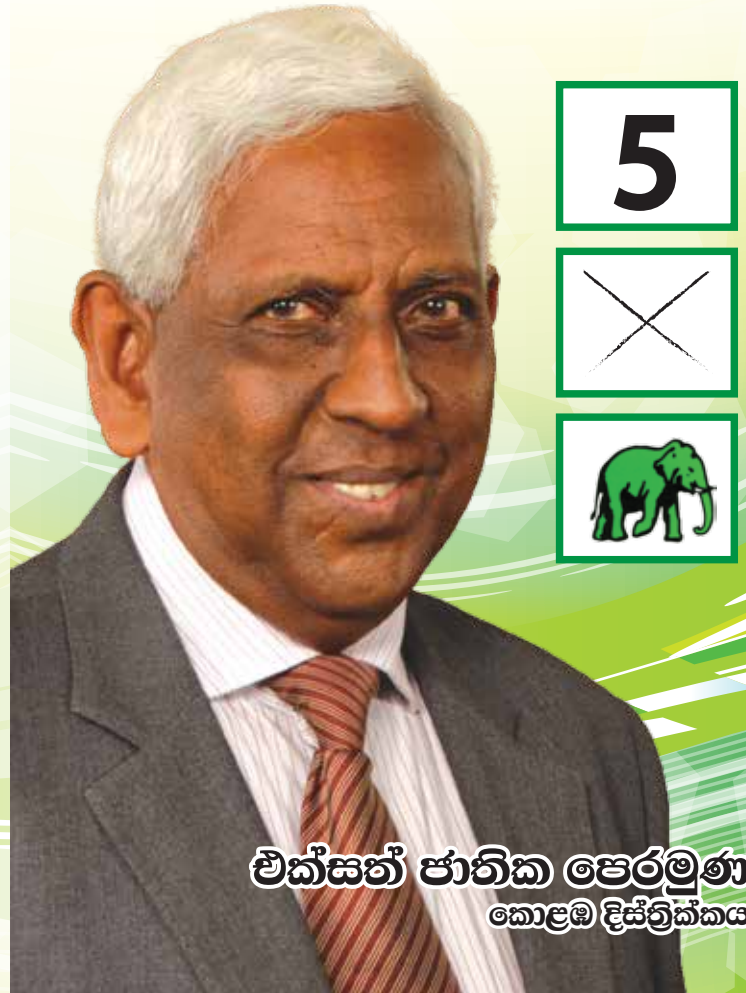
