Re: Appointment of judges who are charged for corruption

I have found that there is an attempt to sabotage the public litigation cases initiated by me in the Supreme Court, purely in the public interest, against those who hold public office in the Legislature, Executive and the Judiciary and are required to perform their office honestly and according to the Constitution and the Rule of Law. They have been charged because they have betrayed the sovereign rights of the people, by deliberately violating the public trust doctrine.

For instance, the Judicial Corruption case (SC/Writs/03/2016, was listed for support before a Bench chaired by Ewa Wanasundara J with Wijith Malalgoda J also in the Bench on 04th Sep 2017 and it was put off even without fixing a date to support the matter. It is a very important case from the viewpoint of the people initiated against 4 former Chief Justices (Sarath N Silva, Shirani Bandaranayake, Mohan Peiris and K Sripavan) and also against Justice Vijith Malalgoda for alleged abuse of office for committing judicial corruption.

Despite the fact that the Registry being duly informed not to appoint the judges who have been charged for judicial corruption (names provided below) and still occupying office in the Supreme Court, I observe that some of the cases being listed before them, thus compelling me to request them to withdraw from hearings, which I believe, is unpleasant for both the judges and myself.
