Semi Annual Meeting 2013 7th September 2013 (Saturday) at 0930 hours Daniel Poor Library, Jaffna College, Vaddukoddai

The Semi Annual Meeting of the Board of Directors of Jaffna College commenced at 0930 hours on September 07, 2013 in the Daniel Poor Library, Jaffna College, Vaddukoddai with the Chairman the Rt. Rev. Dr Daniel S. Thiagarajah in the Chair.

- **01. Opening Devotions:** The Rt. Rev. Dr Daniel S. Thiagarajah, Chairman, JCBD led the members in opening devotions.

05. Matters arising from the Minutes:

(i) Letter from President, Trustees of Jaffna College Funds (TJCF)

The Principal, Jaffna College tabled the letter he received from the President, TJCF the Rev. Richard Huleatt. The following are some important extracts:

Dated: 22 August 2013

"I'm writing in regard to the Trustees offer of an advance which I first contacted you about in a March 19, 2013 email and again in a follow up email July 11, 2013. You initially expressed an interest in exploring this possibility, but as I indicated in the above mentioned emails in order to move forward the Trustees need to know that first, you have authorization from your board to go ahead; second, the exact amount you are in arrears; and third, approval for the Trustees to conduct an independent resource review (at our expense) so we can

get a better picture of the school's long-term health and sustainability. I know you plan to be at the October meeting but if we haven't heard back from you by September 15 funding for an advance will no longer be available"

Dated: 11 July 2013

"Thanks for your letter of June 27 affirming an interest in the Trustee's offer of advancing additional funds to Jaffna College. Before we can proceed however, I need to make sure we are clear about a few things. First, can you indicate to Phil or me the exact amount you are in arrears? I seem to recall you mentioning an amount around \$100,000 but we will need to know the exact figure before we can proceed with the first half of the advance. Second, it wasn't entirely clear to me whether or not your Board has approved the proposal. You said they "tabled" the matter but I'm not sure exactly what that: means. Did they give you authorization to move ahead or is that yet to be voted upon? Third, you may recall that one of the stipulations calls for the Trustees of Jaffna College Funds to conduct, at their expense, an independent review of the school's financial needs and the resources (and potential resources) available to meet those needs. We don't mean to be intrusive; we only want to try and get a clearer picture of the current and future needs of the college. Regarding the terms of the payback your suggestion of 5-7 years is fine or whatever timeline you work out with Phil. Once we have assurance that you have the proper authorization from your Board, permission for us to undertake an independent review, and the exact amount of the advance needed, we can proceed with the first half of the payment as you requested. However, our offer does require that the review either be completed or at least in progress, before the second half of the advance can be issued. Please don't think I'm trying to hold anything up but I just want to make sure we are all fully agreed on the process."

The Board, while discussing on the matter and appreciating the willingness of the Trustees to help the College, wanted to know more clearly about "Independent Resource Review" as suggested by the Trustees.

07. Meeting of the Trustees of Jaffna College Funds (TJCF)

It was reported that the Principal was invited for this meeting on 27th and 28th October 2013 in Boston, MA, USA.

The Board while approving official leave for the Principal to attend this meeting also sanctioned extended leave for the Principal to meet with the Jaffna College Alumni in Canada and UK.

The Rev. D.S. Solomon, Vice Principal was appointed Acting principal during th time the Principal is on leave (21st October to 11th November 2013).

The Officers will be available for any emergency.

08. Process for search of new Principal – Report by Chair, Search Committee

Attorney Ms. Vijula Arulanantham, Chair of the Search Committee for the new Principal for Jaffna College presented a report (Appendix "A").

Recommendations:

- 1. that the Rev. D.S. Solomon be appointed for the post of Principal.
- 2. that the other applicant interviewed, Ms Vasuki Rajsingham, be designated as the deputy Principal, with clear tasks.
- 3. that the present two vice principals to remains as Vice Principals without distinction of seniority with specific tasks.
- 4. that both the Rev. D.S. Solomon and Ms. Vasuki Rajasingham be appointed on a one year probationary basis to be followed by a three year contract entirely based on performance.
- 5. that both candidates to be given specific and separate duties apart from the general duties accompanying the posts.

The Board appreciated the efforts of the 'Search Committee' and thanked them for the recommendations.

After a lengthy discussion, the Board unanimously resolved to appoint the Rev. D.S. Solomon as the Principal of Jaffna College when the present Principal retires on the 24th December 2013 on a year's probation.

It was decided to take up other recommendations at the next meeting.
